#### **Community Transformation Grant**

The Urban Indian Health Institute submitted an application for the Centers for Disease Control and Prevention's Community Transformation Grant (CTG): National Network of Community Organizations. We were approved but unfunded through this highly competitive grant. This means we may be considered for funding in future cycles. However, a number of [states and communities](#) and [national networks](#) across the country received funding. Many of the grants require distribution of funds to sub-recipients.
