## **Conference on AI/AN Maternal/Child Health: Prevention of Birth Defects, Health Promotion, and Disease Prevention**

August 12 - 15, 2012 in Salt Lake City, Utah

Once again, the American College of Obstetricians and Gynecologists (ACOG) and the Indian Health Service (IHS) will offer an excellent Women's Health update. The ACOG/IHS conference is a four-day multidisciplinary course that focuses on practical approaches to health problems of American Indian & Alaska Native (AI/AN) women and their children. It is specifically designed for Nurses, Advanced Practice Nurses, PAs, and Physicians providing care to AI/AN women in IHS, Tribal and Urban facilities. The core content is designed to update and expand maternity care and women's health skills. There are hands-on training opportunities, including optional tracks for

- Advanced Life Support in Obstetrics (ALSO) certification;
- Nexplanon (the new version of Implanon) insertion training; and
- Neonatal Resuscitation Program (NRP) certification.

The faculty includes a diverse group of Indian Health workers past and present.

### **IHS Health Professions Scholarship**

The Health Professions scholarship, offered by the Indian Health Service (IHS), provides financial aid covering tuition, required fees and other educational and living expenses for qualified American Indian and Alaska Native students applying to, accepted by or enrolled in health professions programs. Students take on service obligations and payback requirements on acceptance of their scholarship award. Graduate students and junior- and senior-level undergraduate students receive priority unless otherwise specified.
