mRNA COVID-19 Vaccines for Children Under 5: Dosing and Schedule

This fact sheet contains information about the mRNA COVID-19 vaccines (i.e., Moderna and Pfizer-BioNTech) to help you make the most informed decision possible about getting the vaccine for your child to better protect them, your loved ones, and tribal communities—both urban and rural.

The Centers for Disease Control and Prevention (CDC) currently recommends COVID-19 vaccination for everyone ages 6 months and up.

Both vaccines received EUA for ages 6 months to 4 years on June 17, 2022. Moderna and Pfizer are both safe and effective at preventing COVID-19 for all authorized age groups. This was proven in clinical trials including over 6,000 children ages 6 months through 4 years—some of whom were American Indian/Alaska Native.¹

What is the difference between the vaccines?

While both vaccines are safe and effective, the dosing and vaccination schedule differs between Pfizer and Moderna for younger children. Understanding how many doses your child will need and when they will be fully vaccinated can help you make the best decision for your family.

Pfizer mRNA vaccine For the Pfizer mRNA vaccine, children ages 6 months to 4 years: ³	Receive three 3 microgram doses	Must receive their second dose 4 weeks after their first, and final dose eight weeks after the second	Are considered fully vaccinated three months after their initial dose	

If your child has any adverse symptoms after receiving their vaccine...

Don't worry, these symptoms typically resolve within a few days. Call your provider if any side effects do not go away. In addition, you can report any side effects or concerns to CDC's safety monitoring system at <u>vsafe.cdc.org</u>.
